

Cookie policy

In connection with the use of the website <https://www.4everlogistics.com/> (hereinafter the "Website"), we kindly inform you that **FOREVER LOGISTICS KUBIAK Sp. j.** with its registered office in Łódź (93 - 231); 238 Gen. Jarosław Dąbrowskiego Street, i.e. the **operator and owner of the Website**, uses *cookies*.

Cookies are computer *files* stored on the user's device when using the Website. They are stored each time the Website is used and enable subsequent identification of the user when reconnecting to the Website from the device on which they are stored. *Cookies* usually contain the name of the website they come from, the time they are stored on the end device, a unique number and other necessary data. At the same time, permanent files are used (e.g. for navigation optimisation - stored on the user's device for the time specified in their parameters or until they are deleted by the user) and session files (e.g. allowing the proper functioning of the Website by remembering the resolution selected by the user - stored on the user's device until the end of the browser session).

The owner uses them for purposes:

- **functional** - optimise the use of the Website;
- **analytical** - they allow, for example, the creation of anonymous, aggregated statistics which help to understand the use of the Website by users, in order to improve its structure and content;
- **advertising** - they enable the delivery of advertising content tailored to the user's interests, while making it easier for advertisers to deliver advertising content tailored to the user's needs and interests.

The information contained in the *cookies* used by me on the Website does not allow specific users to be identified, and may potentially only be given the character of personal data if it is combined with personal data provided to me by the user, e.g. in connection with the user making contact with us by filling in a contact form or after the user has given appropriate consent prior to using the offered services (e.g. BLOG). In any such case, you will additionally be informed about the principles of processing your personal data and asked to give your separate consent to the processing of your personal data, insofar as such consent forms the basis for the processing of your personal data.

When using the Website, *cookies* of third parties with whom I cooperate, e.g. Facebook, Google Analytics and Adwords, may be placed on your device.
